#### **Attention Exhibitors**

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of UKC and this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- All dogs must have a UKC registration number to enter any trial.
- Entries will NOT be accepted without fees and signatures.
- Dog's height must be included on the entry form.
- No entry fees will be refunded if the show cannot open or be completed by reason of riots, civil disturbance, fire, extreme and/or dangerous weather conditions, act of God, public emergency or any other cause beyond the control of OKPAWS K9 SPORTS CLUB or the show committee.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused by the veterinarian or judge or barred from competition by action of the show committee.
- Returned checks do not constitute a valid entry. The secretary will add a \$30.00 collection fee to the amount of each returned check. Subsequent returned checks from the same exhibitor may result in their being put on a CASH only basis.
- Concession may or may not be available. SIGN UP SHEETS FOR TAKE
   OUT LUNCHES WILL BE AVAILABLE EACH DAY Lunch cost
   \$10/day/person.
- Exhibitors are expected to be responsible for cleaning up after their dogs.
- Dogs must be under handlers' control or in crates at all times, no dogs may be left tied up AT ANY TIME. No unattended dogs will be allowed to remain on the grounds overnight, but crates and equipment may remain.

- Bitches in season cannot compete, but will be given a refund, if in season the day of trial. Certification from a veterinarian must accompany a request for refund for a bitch in season after the trial closing date. Request for refund, needs to be in the hands of the trial secretary before the start day of the trial.
- Exhibitors alone are responsible for knowing the run order and being at the ring gate when it is their turn to run.
- No food, toys or devices of any kind are permitted on the course.
- Unsportsmanlike conduct, including rough handling or misconduct of any kind, will result in being excused from the ring.
- Entrants can only advance to the next class between trials. Contact event secretary, to move an entry



# UKC COVID-19 RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

- 1. I understand the hazards of the novel coronavirus ("COVID-19") and am familiar with the Centers for Disease Control and Prevention's guidelines.
- 2. While understanding the hazards of COVID-19, I am willing to participate in United Kennel Club ("UKC") and OKPAWS K9 Sports Club activities at my own free will and discretion.
